SUBJECT: Approval of 7-11 March 2016 O-5 and Below Joint Qualification System
Experience Review Panel Recommendations

1. On 7-11 March 2016, the Joint Staff convened a Joint Qualification System experience review panel in accordance with Chairman of the Joint Chiefs of Staff Instruction (CJCSI) 1330.05A, 15 December 2015, "Joint Officer Management Program Procedures." The panel considered 1,174 joint experience nominations, submitted by officers via their respective Services, for joint recognition.
2. Effective immediately, the recommendations of the panels (Attachments A and B) are hereby approved. Specifically, 616 nominations are approved to receive joint experience points, 511 nominations are disapproved, and 47 nominations are returned for rework to be considered at a future panel.
3. Attachment C lists officers who have successfully completed the Afghanistan/Pakistan Hands Program. In accordance with CJCSI 1630.1A, 30 April 2014, "Afghanistan/Pakistan Hands (APH) Program," Enclosure D, these officers will automatically be awarded experience points.
