SUBJECT: Approval of 24 May 2016 O-6 and 17-18 May 2016 O-5 and Below Joint
Qualification System Experience Review Panel Recommendations

1. The Joint Staff convened an O-6 Joint Qualification System (JQS) experience review panel on 24 May 2016 and an O-5 and below JQS experience review panel on 17-18 May 2016 in accordance with Chairman of the Joint Chiefs of Staff Instruction (CJCSI) 1330.05A, 15 December 2015, "Joint Officer Management Program Procedures." The panels considered 40 O-6 and 291 O-5 and below joint experience nominations, submitted by officers via their respective Services, for joint recognition.
2. Effective immediately, the recommendations of the panels (Attachments A and B) are hereby approved. Specifically, 24 O-6 and 180 O-5 and below nominations are approved to receive joint experience points, 12 O-6 and 53 O-5 and below nominations are disapproved, and 4 O-6 and 58 O-5 and below nominations are returned for rework to be considered at a future panel.
3. Attachment C lists officers who have successfully completed the Afghanistan/Pakistan Hands Program. In accordance with CJCSI 1630.1A, 30 April 2014, "Afghanistan/Pakistan Hands (APH) Program," Enclosure D, these officers will automatically be awarded experience points.
